Comment: Erosion degradation is also starting to become evident on slopes of the topsoil stockpile. Areas of the perimeter stormwater ditch appearst to be filling with sediment. Inlet on the southwest corner of the sediment trap filling with sediment.

Advise maintenace.

Erosion degradation evident at the soil stockpile on the southeast corner of the pad. Insufficient inlet protection on the northeast corner of the sediment trap; gully erosion forming.

Corrective Action: Install or repair required BMPs per Rule 1002.f.
