This follow-up inspection to Field Inspection Report (FIR) Document #682402280 and #682402595 was conducted on 2/20/2019 by I, Russell Beam, COGCC Reclamation Specialist at the location.

The following Corrective Actions were observed during the Inspections.

1004.a FINAL RECLAMATION OF WELL SITES AND ASSOCIATED PRODUCTION FACILITIES

There is a well sign still on location. FIRs Document # 682402280 and #682402595 had a corrective action for removal of equipment and submitting a Form 4 Sundry. This is now the third inspection for the removal of the remaining equipment and submitting a Form 4 Sundry supporting a final land use change to housing development. Corrective Action still stands until the equipment has been removed – CA Date 7/19/2017.

Operator is directed to perform corrective actions outlined on this inspection report immediately. Doing so may decrease the duration of the alleged violations and the penalties that may be assessed pursuant to Rule 523.
