INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Five discreet confirmation soil samples were collected on March 1, 2019 (4 wall and 1 base) from the produced water tank excavation. The base and wall sample were analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), gasoline range organics (GRO), and diesel range organics (DRO). In addition, the wall sample was analyzed for pH, Electrical Conductivity (EC), and Sodium Absorption Ratio (SAR). Concentrations of BTEX, GRO, DRO, pH, EC, and SAR were either not detected at or above laboratory reporting limits or were reported below their respective COGCC Table 910-1 concentration levels. See the attached laboratory report, soil analytical table, and figure 3.
