As there's no reasonable way to separate the soil horizons that have been mixed, Elevation would like to work with COGCC Reclamation on a solution. Elevation currently proposes to contact a certified soil scientist contractor to draft a plan to amend the current stockpiles to transform them into useable topsoil for the future.
