

Gentlemen:

Pursuant to Rule 305 (B) of the Colorado Oil and Gas Conservation Commission, please be advised that Noble Energy, Inc. ("Noble") intends to commence the drilling of the above captioned well located in Yuma County, Colorado, at the location shown on the attached plat. It is our plan to drill the captioned well during the course of our 2005 drilling program which will begin in January, 2005.

An Agent for Noble is hand delivering this letter in order to discuss the proposed access for the well road and location. Mr. Dave Ledet is the Noble representative in Yuma, Colorado. Mr. Ledet's telephone number in Yuma is 970.848.0331 (mobile 970.630.1076), should you need to contact him for any reason. A prepaid post card is enclosed, which you may use to notify Noble that you wish to appoint a tenant or other representative for consultation regarding the well location and access route.

A copy of the State of Colorado Oil and Gas Well Notification, Consultation and Reclamation Rules is enclosed for your review and files. Please note that, according to these rules, it is the responsibility of the surface owner to notify any tenants regarding these operations.
