OPERATOR COMMENTS AND SUBMITTAL

Comments Nearest well to the proposed wellbore completed in the same formation: GP Cody Fed 20E-15-3N, operated by Extraction Oil and Gas, Inc.
Nearest well belonging to another operator: grossaint amoco 41-21, API 05-123-16091, operated by Kerr McGee Oil and Gas.
Interwell distances were determined using our in-house 3D anti-collision reports.
Surface location remains the same with a new landing point and bottom hole location. Updated drilling plans and plat are attached. The Surface Use Agreement for this location was signed July 26, 2013 and this location is within a Buffer Zone - document already on-file with COGCC. Extraction Oil & Gas respectfully requests the Director grant an exception as per Rule 604.b.(1)A. & Rule 604.b.(2) - document already on-file with COGCC. Extraction Oil & Gas requests an exception to Rule 318A.a. since location is not within a GWA window. The surface owner waives this Rule in the SUA (highlighted on p.4). Pad has been built. No form 2A is required.

2	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with open-hole resistivity log and gamma-ray log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.
3	Drilling/Completion Operations	Anti-collision: Operator will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice shall be given to all offset operators prior to drilling.
