All documents for registration and financial assurance have been processed and approved for **Waulco Resources LLC- Operator # 10715**. All contact information must stay current per Rule 302.a and 302.b.

On January 5, 2015, the Commission adopted new rules concerning penalties for violations of the Oil and Gas Conservation Act, or Commission rules, orders, or permits. The rule changes implement HB-14-1356, which increased the Commission's statutory penalty authority from \$1,000 to \$15,000 per day per violation and eliminated a \$10,000 cap on penalties for a single violation. The new rules also advance enforcement policies and procedures implemented by the Commission in response to Executive Order D 2013-004.

All operators are encourage to visit our website at www.colorado.gov/cogcc on a regular basis for any updates on policies, rules and regulations, guidance documents, new eform developments, hearings, etc.

Operators with pipelines over which the COGCC has jurisdiction are required by Rule 1102.d to be members of the Utility Notification Center of Colorado and participate in Colorado's One Call notification system.

All operator information is available on our website at www.colorado.gov/cogcc by clicking on the "database" link, then the "name, address and financial assurance" link, and entering your company name or operator number and submit. Any blue highlights are links to more detailed information.

Many of our forms are now available for electronic submittal through Colorado eforms. A list of these forms and instructions can be found at the "Regulations/Form" links. The principle agent and designated agents should have received an email activating their email address, username and password, and a link to the eform Training Manual.

Please use the Surety ID# assigned to your financial assurance for any permits, Form 10's, and Form 12's. All financial assurances are perpetual instruments which shall remain in force and effect until all obligations have been met and released by COGCC.

Please be advised that Form 12 Gas Facility Registration/Change of Operator must be received and approved before operators are granted Gatherer and Downstream Gas Facility operations.
