The Sunmarke 28V-434 (05-123-38901) had 90 PSI on the bradenhead during its annual test. We would like to utilize an existing flowline that is currently on location as an abatement system for all four (4) wells on that South pad (28V-234, 304, 434; 28W-414). PDC is requesting we convert the existing flowlines into bradenhead abatement that will send the fluid to the controlled production tanks.
