Additionally, It appears that stormwater flows breached the access road at the culvert crossing, likely indicating that the culvert is not adequate to convey flow volumes.</p> <p>Corrective Action: Stormwater controls need to be installed to stabilize erosion within the southeastern portion of the project area and along the access road.
