7/16/77

NTA DRILLING COMPANY moved in, rigged up. Spudded well 11:30 a.m.
Drilled to 85' W/6 1/4" bit firm shale. Tripped pipe W/9 7/8" bit,
drilled to 85', circulated hole one hour, prepared to run pipe. 7"
Range 3 was too long for derrick, welder cut & beveled pipe & welded
same in hole. Pipe ran as follows:

4 Jts. 7" Used casing 84.20
Set at 83.20 G.L. broke circulation, cemented W/26 sks. cement W/2% C.C.
W/5 sks. return. Bumped plug W/100 PSI 5:00 p.m., rigged down, W.O.C.

7/21/77

Rigged up, drilled rubber plug, drilled to 120', no water. S.D.F.N.

7/22/77

Cleaned hole, drilled to T.D. 450', returns were damp, used foam to
clean hole. Rigged down.

7/30/77

PATTERSON'S work over rig moved in, rigged up to run tubing, pump &
rods. Started running tubing, dropped 10 jts. due to swivel backing off
while tightening tubing. Fished tubing, laid down, cleaned mud from
perforated sub., ran back in hole. Note: Top 3 jts. was full of oil.
