The following Corrective Actions were observed during the Inspections.

1004.a Final Reclamation. This location is not in compliance with Rule 1004a. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland which should have been 5/4/2015. Well was plugged 5/4/2016. The access road has not been reclaimed fully to Washington St. No 502b variance request for the access road is on file. Please refer to the attached inspection photos for more detail. – CA Date 5/4/2015.
