On 4/17/2019 at approximately 12:00, I, inspector Rick Moran, conducted a follow up inspection at Utah Oil & Gas well Dragon Trail Unit 1050 in Rio Blanco county.

While there I conducted a follow up inspection of FIR document 679702827 along with a routine well inspection.

During this inspection the following possible compliance issues were observed.

- 1) The tank secondary containment liner is torn.
- 2) Trash that ran off from location through a breached berm.
- 3) Storm water run off from location through a breached berm.
- 4) Soil scour on southeast hillside of location.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
