	<p>This location is not in compliance with Rule 1004 standards. Well was plugged and abandoned 9/20/2018. Areas around the well location (~0.25 acres of disturbance) and the access road have observed crop failure. Failed areas around the well location may have been associated with old pits. There appears to be an impervious layer observed approximately three feet below the surface. Operator shall investigate why crop areas are failing within the disturbance areas.</p> <p>It does not appear Final Reclamation activities were performed throughout the access road.</p>	
Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
