Noble has begun work on the Myers 14-21 reclamation, as described in the attached work plan. Noble has regraded the reclamation area and spread topsoil. Noble is in the process of collecting soil samples and surveying the field, at the landowner's request. The landowner is converting this field to alfalfa, which cannot be planted until May. Noble will seed in May in coordination with the landowner. Because seeding has not been completed, Noble has not yet submitted the FIRR.
