Noble has received sample results from samples collected in the reclamation area and in the adjacent field. Noble has developed a reclamation plan, including soil amendment recommendations, based on the sample analytical results (attached).

Noble intends to regrade the field, as described in the previous biweekly submittal, implement the attached reclamation plan, and seed. This work is anticipated to begin by mid-May, weather pending.

Noble has also been in contact with the landowner, and has provided him the attached reclamation plan and the previously submitted survey.
