Operator Comment: Clear Creek re-graded the southeastern area of the True Ranch 23 well pad to establish a berm along the downwind side of the pad. This berm will serve as a barrier from allowing wind blown dust and sand to freely escape location. The berm is approximately 5 ft high. By establishing the berm and pulling back the edge of pad surface, a 6:1 slope was established along the eastern and southern sides of the pad to create a more gradual slope. This will promote more immediate and successful grass growth (i.e. long term stabilization). Prior to spreading stabilization product, the reclaimed area and slopes were surface roughed to allow for hydromulch product to settle into soil depressions for long term effectiveness. A Hydromulch product with a slurry mixture consisting of soil binder, mulch tackifier and perennial seeding mixture was applied as the long term stabilizer.

Operator Comment: Clear Creek personnel manually removed sediment from ditches: The remedy made in as part of the other corrective action will serve to eliminate sediment buildup in the eastern and southern channels. As for the sediment trap, Clear Creek re-sized it to accommodate a volume of 3600 CF/Acre for a disturbed drainage of 7.3 acres for a total volume of 26,280 CF of storage. The Bottom surface area of the sediment trap was sized at 120 ft by 60' and 4 ft in height.
