Corrective Action:	This location is 4 years out of compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 10/11/2013. It does not appear any reclamation work has been performed; gravel remains throughout the tank battery and access road which has not been re-contoured or re-graded; weedy, annual vegetation was observed which includes but not limited to Cheatgrass and Kochia.
