General Comment:Accident Inspection

Per Codell's company owner, at approximately 0630 hrs on 5/2/2019 Codell Well Services workover rig 4 crew was rigging down for the day at well Ma-State 12S. One derrick hand was in the doghouse to heat up breakfast when a flash fire occurred while he was igniting the propane heater. The furnace control valve did not seat allowing gas to leak by causing gas to accumulate in the doghouse. The derrick hand was taken to Hugo Hospital. Some clothing and boots in the doghouse were burned and locker doors at the opposite end of the doghouse were bent from the flash fire. Operator contacted COGCC at approximately 0830 hrs the same day. The Lincoln County LGD will be contacted by the operator. An Accident Report, Form 22, must be submitted by the operator within 3 days of the accident per COGCC Rule 602. Photos are attached.
