**General Comment:**

On 5/8/2019 COGCC Environmental; Staff, Kris Neidel inspected location ID # 312924. The weather was overcast and 45 degrees, the ground surface was dry. The location appears to have been PA'd. No production equipment such as; tanks flowlines, treaters, etc remains on the surface. The access road remains, from county rd 184, to pad, continuing north to the river. The area that contained the production equipment and tanks appears to have been surface tilled or roughened. By 6/10/2019, the operator shall submit a Form 27, Site Investigation Workplan that demonstrates; all remaining soil is compliant with COGCC table 910-1. Field Inspection document number 685100489, dated 7/9/2018, contains a summary of past inspections that mentioned oil stained soils and spills, these areas shall be addressed in the Site Investigation Report. A review of the COGCC database showed a pit, facility id 116688, is associated with the Craig 1-7 well. Status of this pit is unknown, a Separate Form 27, shall be submitted by 6/10/2019 that demonstrates that the pit was closed per COGCC rules.
