**General Comment:**

On 5/9/2019 COGCC Environmental; Staff, Kris Neidel inspected location ID # 458790. The weather was 37 degrees with light flurries the ground surface was dry. Environmental Staff observed the cuttings management area. Crews were moving cuttings from the rig shaker bin to storage bins lined up out away from the rig to the north edge of location. Cuttings are being tracked out of the cuttings management area when loading trucks. The cuttings management is completely covered in cuttings material. No trucks were being loaded at the time of inspection. All cuttings should be managed and stored as E&P, cuttings should be, "stored in a way that prevents threatened or actual significant adverse environmental impacts...to soil..." (COGCC rules 907.a(1)). Crews were installing a French Drain, off location, to the South and east of location. The drain was being installed along the full length of the pad to the south and east, approximately 12 feet deep. It was reported that the drain is intended to discharge to the north east of the pad, (down surface grade). Sandridge should consult with COGCC OGLA staff; Dave Kubeczko and John Noto to determine if an amended 2A is required for this activity. Sandridge should acquire any permits or notices to Division of Water Resources or CDPHE as required for this activity.
