COGCC Inspection Report 689802622 Summary

On Friday 05/03/2019 at approximately 11:32 I, Inspector Emily Waldron, conducted a field inspection at Sandridge Exploration and Production LLC Peterson Ridge 1-20H, API # 05-057-06515, in Jackson County, Colorado.

During this inspection the following possible compliance issues were observed:

Non-reportable spills of stained soil were observed at loadouts, outside of tank battery berm, and on access road. See photos 2, 3, 4, 5, 6, 7, and 9.

Comply with Rule 603.f, by 06/06/2019.

Securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d, by 6/06/2019.

Rills were observed coming onto location on the northeast perimeter. Tracking off of location and onto CO State Highway 14 was observed going both north and south. See photos 8, 10, and 11.

Maintain vehicle tracking BMPs on the oil and gas location to comply with rule 1002.f.(2)F. If material is tracked onto County or public roads, contact the appropriate authority by 5/6/2019.

I spoke with Aaron Cook of Sandridge by phone on 05/03/2019 and continued vehicle tracking was discussed.

On Friday 05/03/2019 at approximately 12:00 I, Inspector Emily Waldron, conducted a field inspection at Sandridge Exploration and Production LLC Patriot 0880 13-32H5, API # 05-057-06618, in Jackson County, Colorado.

During this inspection the following possible compliance issues were observed:

Cuttings not being contained in closed loop system. Cuttings found on entire location. See photos 12-15.

Mud additives uncovered. Silt fence collapsed or otherwise compromised in approximately 7 spots around location perimeter. Sediment migration off location observed at 2 spots. See photos 2-11.

Install or repair required BMPs per Rule 1002.f, by 05/08/2019.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
