I performed the audit at 40.36891, -104.96793.

Noise sources appear to be power generation equipment, located on northwest corner of production facility.

The audit began at approximately 12:34, and concluded at 12:55.

Audit revealed an LEQ 1 average of 60.7 DB, indicating noncompliance with rule 802.b
