**General Comment:**

On April 30, 2019, COGCC Environmental Staff (John Heil and Steven Arauzo) conducted an environmental field inspection of TEP ROCKY MOUNTAIN LLC (TEP operator #96850) Spill ID 464253.

Operator reported a spill of produced water from a hole in a 12 inch water pipeline, located 1.6 miles south of the Crawford Trail Compressor Station. Approximately 100 BBLs of water was recovered by vac-truck and it is estimated that 30% of that volume was precipitation that was running into the excavation (Doc #402024312).

The pipeline was excavated and repaired prior to inspection date. The pipeline repair was visible inside an open fenced excavation on inspection date. The excavation measured approximately 90 feet by 30 feet wide by 25 feet deep (see photos). There were two soil stockpiles, north and south of the excavation. The stockpiled soil had earthen berms and were approximately 60 feet by 60 feet by 30 feet tall (see photos). Sidewalls and bottom of excavation around the pipeline were moist and there was a strong hydrocarbon odor at the time of the inspection.

The excavation is located in the path of a drainage that originates at the road (see photos). Waddles were placed to the east side of the excavation (down gradient) and in the drainage to the east (see photos).

**Environmental****Spill/Remediation:**
