**General Comment:**

On April 17, 2018 COGCC Environmental Staff (Alex Fischer, Steven Arauza, and John Heil) conducted an environmental field inspection of Laramie Energy LLC's (Laramie) CC 604-41-32 Pad (Location ID: 335902). The purpose of the inspection was to document current conditions of the Location as it pertained to a Rule 502.b. variance request from the operator (See Document Number 402030527). At the time of the inspection the weather was partially sunny and temperatures about 50 degrees Fahrenheit.

The following is a summary:

- Pad sign reads "Pond 3" and does not identify pad by Location Name.
- Pad contains 20 wells with conductor casing set inside of open cellars.
- Concrete pad with flowline risers on south side of pad.
- Approximately 4 to 6-inches of new road base had been recently placed and compacted over the surface of the Location.
