After setting surface casing, well was drilled to a total depth of 5387' and electric logs run. One (1) Drill Stem Test was run from 5114' to 5122' but since there was no significant show of oil or gas, well was plugged and abandoned as follows:

- 25 sack cement plug from 150' to 200'
- 10 sack cement plug from surface to 30 feet.

Hole was filled with heavy mud, bottom hole cement plug was waived by Commission Representative Jim McKee on 3/31/87.
