General Comment:

On April 17, 2018 COGCC Environmental Staff (Alex Fischer, Steven Arauz, and John Heil) conducted an environmental field inspection of Laramie Energy LLC's (Laramie) CC 696-03-07Pad (Location ID: 452807). The purpose of the inspection was to document current conditions of the Location as it pertained to a Rule 502.b. variance request from the operator (See Document Number 402030567). At the time of the inspection the weather was partially sunny and temperatures about 50 degrees Fahrenheit.

The following is a summary:

- No facility sign at access road or at entrance to facility.
- Pumping operation with filters was observed at tank battery on inspection date. Battery was not inspected by COGCC staff.
- Site-wide unused equipment (pipe) and junk/trash (pallets, wood debris, trash, food).
- Uncapped flowline riser with hammer union south of separator with sign for CC 0697-03-13E.
- Site-wide localized accumulations of oil-stained soil, notably beneath separators and in frac tank area along north and northeast sides of pad, beneath almost every one of the existing wellheads.
- Three (3) plastic 55-gallon plastic drums stored south of wellheads lack secondary containment devices. One drum was overturned on date of inspection.
- Two (2) 1,000-gallon diesel fuel tanks inside of secondary containment.
- Cuttings from initial occupation remain piled atop cut slope on south side of pad.
- Food waste (cooked vegetables) observed on pad. Form 2A (doc #401387622) included specific BMPs for food/waste management program and education program that reduces bear conflicts.
