Plugged as follows:

Filled hole with heavy mud from 5268' to 4964'. Cemented and displaced through drill pipe 35 sacks cement from 4964' to 4810'. Fill hole with heavy mud from 4810' to 210'. Set second plug 210' to 180' with 10 sacks cement. Fill hole with heavy mud from 180' to 15'. Plugged top of surface with 5 sacks cement from 15' to base of well cellar.

Filled hole with heavy mud from 5268' to 1881'. Cemented and displaced through drill pipe 25 sacks cement from 1881' to 1891'. Filled hole with heavy mud from 1891' to 1901'. Set second plug 210' with 10 sacks cement. Filled hole with heavy mud from 1901' to 191'. Plugged top of surface with 5 sacks cement from 191' to base of well collar.
