Comment: Bare soils within the eastern project area, and areas currently vegetated with annual vegetation due to spring precipitation, are not stabilized.

Corrective Action: Stormwater controls designed to stabilize erosion and sediment are needed while interim reclamation ins conducted, and until location is stabilized with perennial vegetation. Stormwater controls need to be selected, sized, and installed in accordance with good engineering practices such as those described by CDOT in their erosion control manuals.
