Soils and Liquids from the Skim Pit were Excavated and disposed of at a waste management facility. 1000 gallons of liquids were disposed of at CSI and approximately 99 tons were disposed of at a waste management facility. The east side of pit had to be rebuilt to maintain integrity of evaporation pit. Waddles were installed on the south side of evaporation pit, and fenced in due to cattle. The area south of the east pit was cultivated and grass was planted in November 2018.
