Five grab soil samples will be collected. Three from the pit bottom, one from the pit overflow discharge point, and one background soil sample collected away from the pit. The three pit bottom and one discharge point soil samples will be analyzed in accordance with Table 910-1 with the exception of barium analysis as discussed with Kris Neidel of COGCC on September 25, 2018. The background soil sample will be submitted for analysis of arsenic and conductivity and will be used in comparative analysis with the pit soil sampling results.
