Comment: Stormwater controls have been installed, but are not maintained and erosion continues within the eastern and southeastern project area. Concentrated stormwater flows from the well pad are not sufficiently de-energized to prevent downstream erosion within these areas.

Corrective Action: Additional stormwater controls are needed to stabilize erosion from concentrated well pad run-off within the eastern and southeastern project area. Stormwater controls should be selected, sized, and installed using good engineering practices.
