While there, I observed Production.

During this inspection the following possible compliance issues were observed:

Tanks are same size. One labeled 300 BBL, one labeled 400 BBL see photos 2, 4, 5. Install sign to comply with Rule 210.d by 7/3/2019.

Corrosion holes forming in upper half of northern tank see photos 2 and 3. Securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d by 7/3/2019.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
