In aerials, site footprint does not appear reduced since the one PR Well on site was Spud in 1993. 2A to Amend Existing Location was Approved 11/5/14; Expiration Date 11/4/17; Size of Location after Interim Reclamation to be 1.83 acres. Areas No Longer needed for Use have not been reclaimed. There is evidence that areas have been seeded (emerging vegetation in drill row patterns), though re-contouring and replacement of soils not performed. Area in back (to NW) of Separators is being used for storage of Material stockpiles. There is not a Request for a Delayed Interim Reclamation Variance submitted for this Location.
