Cub Creek Energy is requesting an exception to ground water sampling per Rule 318A for the following reasons. LT Environmental, Inc. (LTE) conducted research of the available water sources in the governmental quarter sections located within one-half mile radius of the proposed drilling location. The following well receipts numbers were found to be unacceptable for sampling purposes.

Well Receipt #906492 - LTE contacted the landowner on 5/22/19 and, per the owner, the well had been drilled but never had a pump installed and the well has never been used.

Well Receipt #0470802 - LTE contacted the landowners on 5/22/19 via phone and again on 5/23/19 but there was no answer or messaging service. LTE sent a letter, via FedEx Express, to the owners requesting access to the well on 5/24/19. LTE has not received a response from the owners.

Well Receipt #9061396 - LTE contacted the landowner via telephone on 5/22/19 and, per the owner, no water wells exist on the property.

Well Receipt #0312736 - This is a closed loop Geothermal well for heating the household. LTE made attempts to contact the owner on 5/23/19 and 5/28/19, but there was no answer, answering service, or returned calls.

Well Receipt #0457862 - This well was previously sampled (sample ID755390) on 12/12/16 and exempts this the governmental quarter section (Qtr -SE, Sec 20, T3N, R68W, 6th PM).
