	<p>Previous inspections documented gravel remaining on location and access road, that location/access road has not been regraded, recontoured, or had compaction alleviation conducted and erosion concerns were evident on the south end of the location. Previous inspections required operator to conduct reclamation.</p> <p>Unable to find evidence that reclamation activities have been conducted in accordance with COGCC 1000 series reclamation requirements, and corrective actions. Gravel remains on location/road. Road and location have not been regraded, recontoured, or have had compaction alleviation. Location remains predominantly bare/exposed soil. Erosion concerns remain evident on the south end of location. Corrective action has not been addressed</p>	
Corrective Action:	<p>Perform reclamation in accordance with COGCC 1000 series rules including, but not limited to, removal of gravel/road base, compaction alleviation, recontour/regrade, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on the location and access road. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.</p>	Date <b>10/31/2016</b>
