While there, I observed a producing well.

During this inspection the following possible compliance issues were observed:

Soil pile stored on location with wattles around it. Wattles have become debris and sediment is migrating through the wattles away from the pile. See photos 3 and 4. Install or repair required BMPs per Rule 1002.f by 7/5/2019.

Fresh gravel adjacent to wellhead. See photo 2.
