Noble has re-graded the field, as described in previous biweekly submittals. The final grade of the field has been surveyed, and the survey is attached. Noble believes the field has been properly graded and no additional grading activities are planned.

The landowner has requested that Noble plant Roundup-Ready alfalfa. Once the landowner provides a registration number to allow the use of Roundup-Ready seed, Noble will purchase and plant the requested seed mix.

Noble is also working with the landowner to agree on a plan to properly de-compact the disturbance area prior to seeding. The landowner has requested that Noble disc the area to a depth of 4-6 inches. Noble would prefer to deep rip to 18-inches in accordance with COGCC Rule 1004.
