PUBLIC NOTICE OF PROPOSED UNDERGROUND INJECTION CONTROL PERMIT

PURPOSE OF PUBLIC NOTICE:
The purpose of this notice is to solicit public comment on the EWS-4B injection permit submitted by EWS 4 DJ Basin LLC. The EWS-4B is a new directional well drilled for commercial EPA-Class II disposal. EWS-4B will be the third well in the existing EWS 4 Disposal Facility with the operational disposal wells EWS-4 and EWS-4A. The EWS-4B surface location is 2193 ft (feet) from the south line and 483 ft from the east line in the NE/4 of the SE/4 of Section 18, Township 2 North, Range 63 West, 6th P.M., Weld County, Colorado. The bottom hole is located 1650 ft from the north line and 1858 ft from the west line of Section 20.

BACKGROUND
Class II injection wells are permitted and regulated in such a manner as to prevent the contamination of underground sources of drinking water and to ensure fluid emplacement and confinement within the permitted injection zones. Class II injection wells are permitted to inject waste generated from oil and gas exploratory and production operations. EWS 4 DJ Basin LLC proposes to inject these fluids into the Blaine (9,423-9,456 ft), Lyons (9,456-9,599 ft), Lower Satanka (9,599-9,946 ft), Wolfcamp (9,946-10,031 ft), Amazon (10,031-10,104 ft), Council Grove (10,104-10,288 ft), Admire (10,288-10,334 ft), Virgil (10,334-10,650 ft), Missouri (10,650-10,730 ft), and Fountain (10,730-11,196 ft) (measured depths) Formations in the EWS-4B through an open-hole completion using a slotted liner.

Public comments are encouraged and will be accepted, in writing at the Commission for a period of thirty (30) days after publication of this notice. If any data, information, or arguments submitted during the public comment period appear to raise substantial questions concerning proposed injection well permit, the Director may request that the Commission hold a hearing on the matter.

Additional information on the operation of the proposed injection well may be obtained at the Commission office.
