#### COMMENTS:

Noble Energy requests that the mitigation option be changed from a 1 or 2 to and Option 4. While working on the well to P&A prior to frac, Noble was able to set primary plug isolating the Niobrara and placing 2 sacks on top of the cast iron bridge plug and also able to place a plug across the Sussex (CICR @ 4419' and 225sx behind pipe). When going in to do the additional CICR at 2500', the wireline and CICR continued getting tagging shallow depths (~350'). Unable to place the CICR and butting up close to the frac date, Noble rigged off the well and placed pressure monitoring equipment on the casing and surface casing valves. Noble respectfully requests that the COA for this well be changed from Option 1 or 2 to Option 4.
