-Cut casing ~18" from surface. Remove mandrel
-Back off damaged casing with left handed overshot
-Install new casing, Pull to 120K#, engage slips, and torque down seals
-Install wellhead B section. Pressure test B section to 12K psi and casing to 9K for 15 minutes.
-Retrieve both RBP's release WO rig and all associated equipment
