-RIH with RBP. Set at 1,600'. This insured that we have two forms of isolation.  
-Rig Down Frac Tree and Well Head B section.  
-MIRU WO Rig.  
-Confirm Leak Depth at top pup joint in the casing collar ~4' from surface with compression packer  
-Cut casing ~18" from surface. Remove mandrel.  
-Back off damaged casing with left handed overshot  
-Install new casing, Pull to 120K#, engage slips, and torque down seals.  
-Install wellhead B section. Pressure test B section to 12K psi and casing to 11K for 15 minutes. Good Tests.  
-Retrieve both RBP's release WO rig and all associated equipment.
