This is a bi-weekly report required by a COGCC inspection (document number 682404500). Please route to Chris Binschus.

Following discussions with the landowner and COGCC, Noble is prepared to de-compact and plant alfalfa. Prior to conducting this work, Noble is planning to collect additional soil samples to assess the soil's suitability for alfalfa growth. Noble had scheduled the sampling for the week of June 24th, but due to heavy rains, the field was inaccessible. Noble has tentatively scheduled the sampling for the week of July 1st, weather permitting.

On the morning of June 28th, the landowner notified Noble that an independent agronomist would review the soil in the disturbance area. The landowner requested that Noble hold off on any de-compact or seeding.
