<p>This location is not in compliance with Rule 1004 standards. Well was plugged 4/20/2018. Reclamation rules require the Operator to make every reasonable effort to complete reclamation before the next local growing season. It appears the Operator has missed 2 growing seasons. Operator has failed to properly contour all disturbance areas, failed to perform final reclamation (FR) activities, and failed to remove all gravel. Operator has failed to re-install a fence along a property line and failed to properly re-install gates. Operator has only performed FR along a portion of an access road but has failed to control noxious and undesirable weeds.
