Perform reclamation in accordance to COGCC 1000 series reclamation rules. Perform compaction alleviation, re-grade/re-contour access road to that of the adjacent reference areas. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/15/2016

Operator Comment: The former access road was deep ripped to alleviate compaction and reseeded using a dry prairie seed mix on June 19, 2019. Bare areas on the former well pad were also ripped and reseeded. The remaining portions of the former well pad, and some area outside the fence adjacent to the former well pad with reduced growth, were overseeded.
