Comment: appears no correctice actions for controlling erosion from previous inspection doc# 680603317 have been completed. Prominent erosion channels going off southeast side of pad with no erosion control BMPs (see photo doc). Corrective action date retained to show days of non-compliance.

Corrective Action: Stormwater controls (run-on and runoff) need to be installed to stabilize erosion within the project area by December 21, 2018. Erosion controls such as mulch, hydromulch, or erosion blankets are needed on the well pad cut-slope until vegetation becomes established. This should be installed in coordination with seeding efforts described above
