Work on the remote wellhead location consisted of disassembly of the pumping unit. The horsehead and walking beam were removed. The A-frame was cut off pumping unit base and laid down. Counter weights were removed to decrease weight of pumping unit base. The pumping unit base was cut into (3) sections for loading. Unit is ready for haul off and removal. The wellhead flow line that ran to the well manifold on the production facility was excavated and cement plugged and abandoned. Cement plugged end at wellhead GPS is 40.1579921/-102.831980. GPS at manifold end point is 40.123236/-102794673.
