While there, I observed a shut-in location.

During this inspection the following possible compliance issues were observed:

Frack sand spilled on location. See photo 2. If spilled, released or dumped onto ground surface follow material handling and guidance per MSDS or product data sheet. Submit document, procedures, and waste disposal manifest to COGCC field inspector by 7/5/2019.

Site degradation occurring. All location stormwater BMPs need maintenance. See photo 1. Install or repair required BMPs per Rule 1002.f by 8/2/2019.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
