Comment: Stunted crop growth was observed within the excavated area associated with the spill/release- refer to the attached inspection photos. Operator will have to investigate the reclamation issue. Operator shall perform soil analysis and coordinate with the surface owner on the potential need to re-contour. As noted in the previous inspection from 2018, a corrective action was issued to properly contour to match the surrounding area to allow for successful flood irrigation.
