The grass that was planted on location in the spring is coming up nicely.

OPERATOR COMMENT AND SUBMITTAL

Comment: Upon receiving the FIR, we immediately contacted Green Earth, Inc, and had them go on location and mow down all weeds and also review the growth of the grass that was planted in the spring. They were able to get the weeds mowed on Tuesday, June 18. On Wednesday, June 19, we met with Bob, and Mike, the owners of Green Earth, Inc. and reviewed the location. Weeds are mowed down, and grass is coming up nicely. We also reviewed the 2 bare spots on location, and we have a plan with Green Earth to bring in some top soil, and re-plant the area, in the fall. We have a plan with Green Earth to mow the weeds once every 4-6 weeks, and they will be monitoring the location throughout the summer and fall to ensure the weeds are managed.
