Comment: There is a meter shed, piperisers and tipped over barrel located 2500 feet northeast of the well site by CR 50 & T. The well site is located in cropland which is planted with Sorghum this season. The crop has not reestablished at the location or along the access road. This is the first growing season since equipment removal. There may be possible soil issues at the location affecting crop growth. See Attached Photos

Corrective Action:	Comply with 1004 Rules Remove meter shed, pipe risers, and barrel located 2500 feet NE of the well. Ensure soils are properly decompacted to 18 inches and suitable for crop growth. This may require soil sampling and adding soil amendments per the sampling results. Prepare the location before the next planting season per landowner ag activity.	Date	08/09/2019
